TIME

• All set up must be done on the day and full instruction will be provided in advance of the event. Bump in is 8.00am and bump out is from 2.30pm. Trading is strictly from 10.00am until 2.00pm.

STALLS & ALLOCATION

- Stallholders must be set up by 9.30am on the day.
- Stallholders running late or are unable to attend must contact Lisa Doust by 8.00am on the day.
- Stallholders may not swap stall locations or set up outside the stall areas.
- Public access ways must be kept clear and open at all times.
- General rubbish bins will be provided the day but all non-recyclable or non-compostable waste must be taken away. No rubbish is to be left on the premises.

BOOKINGS & PAYMENT

- Stallholders must read the Terms and Conditions and complete and submit the Application Form.
- Please do not send payment until your application has been approved. Once approved you will be sent an invoice with EFT/cheque details, and full payment must be made by the due date on your invoice. Stall fees are exclusive of GST.
- Stall allocations and an accompanying map of stall locations will be issued closer to the date.

CANCELLATION POLICY

• If you cancel your booking before 30 August 2019, a reimbursement minus a \$50 administration fee will apply. Cancellations after 30 August 2019 will not be reimbursed.

INSURANCE

- Public Liability Insurance of \$10 million is compulsory for all stallholders and must be current at the date of The Love Affair.
- Stallholders must provide a current Insurance Policy Certificate showing the insurer, limit of liability and expiry date.
